DELICIOUS WISHES INSTANT WIN GAME & SWEEPSTAKES Official Rules

NO PURCHASE NECESSARY TO ENTER. MAKING A PURCHASE WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Delicious Wishes Instant Win Game & Sweepstakes ("Promotion") is sponsored by Mondelēz Global LLC ("Sponsor"), 100 Deforest Avenue, East Hanover, NJ 07936 and is administered by Twelve Thirty, LLC ("Administrator").

- PROMOTION PERIOD: The Promotion begins at or about 12:00 AM (midnight) Eastern Time ("ET") on November 1, 2024 and ends at 11:59:59 PM ET on December 25, 2024 ("Promotion Period"). The Promotion consists of an instant win game ("Game") and a sweepstakes ("Sweepstakes"), each as described below. The Administrator's computer is the Promotion's official clock.
- 2. ELIGIBILITY: This Promotion is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees, officers and directors of Sponsor, Administrator, HMT Associates, Inc. and any of their respective owners, parent companies, affiliates, directors, subsidiaries, representatives, advertising, promotion and production agencies or agents (collectively, the "Promotion Entities") as well as their immediate family members (defined as including spouse; biological, adoptive, and/or step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) and persons living in the same household (whether related or not) of any of the above are not eligible to enter or win. Void outside the 50 United States/the District of Columbia and where prohibited by law. All federal, state and local laws apply.

Participation constitutes entrant's (and entrant's parent's or legal guardian's if entrant is deemed a minor in the jurisdiction in which s/he resides ["Minor"]) full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of registration. Entrants will not be allowed to change their physical address or e-mail address on a submitted registration. If it is discovered or suspected that an entrant has registered or attempted to register for the Promotion more than once per calendar day using multiple e-mail addresses or multiple identities, all of that entrant's Game Plays (as defined in Rule 3, below) and Sweepstakes entries (as described in Rule 4, below) will be declared null and void and any prize that he/she/they might have been entitled to win will not be awarded and will be revoked. Use of any automated system or any like methods to participate in the Promotion is prohibited and will result in disgualification of any entrant attempting such use.

3. HOW TO PLAY THE GAME: During the Promotion Period, eligible entrants must visit delicious-wishes.com ("Website") and submit their valid e-mail address. If you choose to access the Website via a mobile device, standard message and data rates may apply in accordance with your mobile service plan. A mobile device is not required to enter. If it is the entrant's first time participating in the Promotion, the entrant must first complete and submit the registration form with all required information, which may include, but may not be

limited to, first and complete last name (no initials), telephone number, street address (no P.O. Boxes will be allowed), city, state, ZIP Code, and date of birth. After registering or (submitting a valid e-mail address on subsequent days), the entrant must then follow the on-screen instructions to play the instant win game ("Game Play"). After a Game Play, the entrant will receive notification on the Website screen as to whether the entrant is a potential "Instant Winner" as well as an e-mail notification (each, and collectively, "Notification"). Each entrant who receives a winning Notification will be deemed a potential Instant Winner of a Game Prize (as defined in Rule 6) subject to verification of the entrant's eligibility and compliance with these Official Rules, as determined by Sponsor and Administrator in their discretion. An entrant is not a winner of any prize, even if the Notification should so indicate, unless and until entrant's eligibility and the potential winning Game Play have been verified and entrant has been notified that verification is complete. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. LIMIT: There is a limit of one (1) Game Play per person/e-mail address per day during the Promotion Period. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Promotion Period.

- 4. HOW TO ENTER THE SWEEPSTAKES: During the Promotion Period and upon completion of a Game Play, an entrant will automatically receive one (1) entry into the Sweepstakes. Limit: Each entrant is limited to receiving one (1) entry per day during the entire Promotion Period. If more than one (1) entry per day is received from the same person, telephone number, address, or e-mail address, all entries associated with such person, telephone number, address, or e-mail address will be disqualified.
- 5. RANDOM DRAWING: On or about December 26, 2024, the Administrator will randomly select one (1) potential Sweepstakes Prize winner from all eligible entries received during the Promotion Period ("Random Drawing"). The winner is considered a potential winner pending verification of his/her/their eligibility and compliance with these Official Rules.

6. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

a. Game Prizes (320 total): The following prizes are available in the Game (each a "Game Prize"):

No more than three hundred twenty (320) Game Prizes will be awarded for any reason. If, due to a technical, production, human or other error, more than three hundred twenty (320)

entrants receive a winning Notification, the three hundred twenty (320) intended Game Prizes will be awarded in a random drawing from among all recipients of such Notifications. No other Game Prizes will be awarded in this Promotion. The total ARV of all Game Prize is \$57,750.

- b. Sweepstakes Prize (1): The "Sweepstakes Prize" is \$10,000, awarded as a check made payable to the Sweepstake Prize winner. Only one (1) Sweepstakes Prize will be awarded in this Promotion. If, due to a technical, production, human or other error, more than one (1) entrant receives a Sweepstakes Prize-winning Notification, the one (1) intended Sweepstakes Prize will be awarded in a random drawing from among all recipients of such Notifications. The ARV of the Sweepstakes Prize is \$10,000.
- **c.** Total ARV: The total ARV of all available prizes in the Promotion is \$67,750.
- **d.** Odds of Winning: The odds of winning a Game Prize depend on the number of eligible Game Plays during the Promotion Period, the number of Game Prizes available at the time of a Game Play, and when the entrant completes a Game Play.

Game Prizes will be made available at three hundred twenty (320) randomly predetermined times throughout the Promotion Period. Use of the prepaid Retailer Gift Card is subject to the terms and conditions imposed by the issuer.

HOW TO CLAIM A PRIZE: Each potential winner will be notified by e-mail with instructions on how to claim their prize, including the potential Sweepstakes Prize winner signing and returning an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days, or the prize may be forfeited in its entirety and awarded to an alternate winner as described below, at the Sponsor's sole and absolute discretion. The e-gift cards will be sent via email to the email address provided by the verified winner during registration while all other prizes will be mailed to verified winners at the street address provided at the time of registration within approximately eight (8) to ten (10) weeks from the end of the Promotion Period, following verification of winners' eligibility. Sponsor will issue an IRS Form 1099-MISC to the Sweepstakes Prize winner for the value of the Sweepstakes Prize. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for any prize won. Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Promotion e-mail, including any winner notification e-mail, to a spam or junk folder. The Released Parties are not responsible for any incorrect or inaccurate information, whether caused by any Website users, tampering, hacking or by any of the equipment or programming associated with or utilized in the Promotion and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Website or any Promotion- related website(s).
